Call to Order

Joe Kenney, Executive Counselor, representative of 108 towns and 4 cities was present and asked during Public Input to provide an overview of his work. He explained the functions of the Council including voting on state contracts, approve board and commission appointments, and voting on judicial appointments. Mr. Kenney also outlined upcoming contracts, projects, and appointments the Council will be working on. He also explained the water drinking grant that may be available to many communities as well as programs supporting economic development projects.

The Board reviewed the Military Leave Policy and it was noted clarification is still needed to assure other medical coverage is available should military leave exceed 30 days. TA Kinmond will continue to follow-up on this.

The Board reviewed the policies Ms. Swenson edited as reviewed at the last workshop session.
