### Call to Order

Chair Swenson called the continuation of the May 23, 2018 Board of Selectmen meeting to order at 9:02am.

Chair Swenson stated the Alton Board of Selectmen met last night for a presentation by Mr. Quimby of the Cyanobacteria Mitigation Committee. Chair Swenson stated he requested the Alton Board of Selectmen take action relative to the structural piece of the watershed management plan in a similar manner as the New Durham Board had acted on May 23, 2018. The Alton Select Board unanimously passed similar motions as to the New Durham action.

Selectman Veisel stated the Building Inspector John Abbott requested the Board review permit fees and explained the Town is losing money for him to go out and do the inspections. Chair Swenson asked Town Administrator Kinmond to add to the agenda of the June 4 meeting a discussion of the Impact Fees as well as the permit fees.

Chair Swenson made a motion to enter into nonpublic session pursuant to RSA 91-A: 3 II (a) – the dismissal, promotion or compensation of any public employee or the disciplining of such employee; (b) – the hiring of any person as a public employee; (c)- matter which, if discussed in public would likely affect adversely the reputation of any person, other than a member of the public body itself, unless such person requests an open meeting. This exemption shall extend to any application for assistance or tax abatement or waiver of a fee, fine or other levy, if based on inability to pay or poverty of the applicant & (e)- Consideration or negotiation of pending claims or litigation which has been threatened in writing of filed against the public body or any subdivision thereof, or against any member thereof because of his or her membership in such public body, until the claim or litigation has been fully adjudicated or otherwise settled. Selectman Veisel seconded the motion.

Motion passed 3-0-0.
