Call to Order

Chair Swenson called the meeting to order at 9:00am.

2018 Budget Review

A revised listing of the capital reserve accounts was distributed and reviewed by line. Discrepancies between the list and amounts approved by the Board of Selectmen were discussed for clarification.

Chair Swenson made a motion to approve the capital expenditure from the Capital Reserve Funds per the list reviewed on December 4, 2017 in the amount of \$859,700. Selectman Chase seconded the motion. Motion passed, 3-0-0.

Chair Swenson made a motion to approve the ETF expenditures of the 2018 budget in the amount of \$60,700. Selectman Chase seconded the motion. Motion passed, 3-0-0.

Chair Swenson made a motion to approve the general trust fund transfers for the 2018 budget in the amount of \$10,671. Selectman Doherty seconded the motion. Motion passed, 3-0-0.

The Board reviewed the capital expenditures for warrant articles.

Chair Swenson made a motion to approve the new taxation to CRFs for the 2018 budget in the amount of \$549,000. Selectman Doherty seconded the motion. Motion passed, 3-0-0.

The Board reviewed the ETF expenditures.

Chair Swenson made a motion to rescind the prior motion for the CRF for the new taxation. Selectman Chase seconded the motion. Motion passed, 3-0-0.

Chair Swenson approve the CRF new taxation amount per the list of the December 4, 2017 in the amount of \$340,000. Selectman Chase seconded the motion. Motion passed, 3-0-0.

Chair Swenson made a motion to approve \$209,000 to the 2018 Budget for the roads, going into the article to define the road expenditures to be combined with the grant and other CRF withdrawals. Selectman Doherty seconded the motion. Motion passed, 3-0-0.

Chair Swenson made a motion to approve the ETF new taxation for the 2018 budget in the amount of \$70,500. Selectman Chase seconded the motion. Motion passed, 3-0-0.

The Board reviewed the tax-rate impact for the 2018 budget and compared to the 2017 budget. Chair Swenson noted its approximately \$0.80 increase for the CRF and ETF piece. The calculations were reviewed and discussed.

Selectman Chase made a motion to rescind the prior motion to put \$340,000 into CRFs which would be raised from taxation. Chair Swenson seconded the motion. Motion passed, 3-0-0.

Chair Swenson made a motion to approve the CRF new taxation in the amount per the amended list of December 4, 2017 in the amount of \$234,000. Selectman Chase seconded the motion. Motion passed, 3-0-0.

<u>Selectman Chase made a motion to rescind the prior vote approving the 2018</u> <u>expenditures of \$859,700. Chair Swenson seconded the motion. Motion passed, 3-0-0.</u>

Selectman Chase made a motion to approve \$753,700 to be spent on 2018 project expenditures per the amended list of December 4, 2017. Selectman Doherty seconded the motion. Motion passed, 3-0-0.

Chair Swenson will summarize the fund balance information and submit to Town Administrator Kinmond.

Selectman Chase made a motion to approve the revenue budget for 2018 in the amount of \$1,721,761 per the detailed list reviewed December 4, 2017. Selectman Doherty seconded the motion. Motion passed, 3-0-0.

Other

Town Administrator Kinmond stated he received additional information from insurance providers and will be providing a summary of the options for review by the Board of Selectmen at the next meeting.

Town Administrator Kinmond stated he was made aware of the Copple Crown revenue report may have been incorrectly calculated and thus the tax rate was inflated. Chair Swenson stated he discussed this with someone from Copple Crown and it was suggested they look at the assessed value as well and to have the board sit down with the finance officer and Town Administrator Kinmond to work on correcting the errors.

Selectman Chase left the meeting.
