Review of draft February 11, 2019 meeting minutes:

Motion was made by Tatiana to approve the February 11, 2019 meeting minutes as amended. (Spelling and punctuation corrections.) Scott D. seconded the motion. There being no additional discussion the Chair called for the vote. Vote was 4-0-0 in favor to approve.

Approved copy was placed in the vertical standing file, in the meeting room of the town hall, following the close of this meeting.

Engineering work site plan:

Received a bill, from Norway Plains Associates, Inc for services to date, total amount \$2,395.00. Invoice number is 31422, work for the site plan against PO # 2598 in the amount of \$2,395.00 to be withdrawn from the Boodey Fund Account # 01-1010-35-000. Motion made by Tatiana to approve a check request from the Boodey House Fund Account for Site Plan Engineering for PO #2598, from account number 01-1010-35-000, totaling \$2.395.00. Total bill for invoice #31422 is \$2.395.00. Scott D. seconded the motion. There being no additional discussion or abstentions stated, the Chair called for the vote. Vote was 4-0-0 in favor to approve.

The Committee reviewed information provided by the engineering firm regarding septic use and trips per day for traffic counts and other items related to zoning regulations. The Chair will share feedback to the engineers.

The Committee reviewed the Chair's financial records. As of March 4, 2019, the Boodey Fund account, according to the Chair's records, and excluding any accumulated interest since 8/28/18 is \$14,285.86.

The Committee would like to publish a newsletter around May. Possible topics for this edition: Promote Site Celebration Day, the artisans on page 1. Scott will draft the story. Members Bios, we will each write a brief Bio about ourselves. Old recipes, Tatiana will provide a few. Family history for the Boodey and Randal families, Cathy will do, with assistance from Crissa. Interview someone connected to the Boodey family. Status and outcomes of current events and activities.

Very brief conversation began regarding the article about fundraising success. The chair provided a form for the members to use as a guideline for answering the questions for fundraising success.

We will meet at 8:15 to begin setting up. We will feature the marketing plan, student's work, donation jar, hand out information cards, and newsletters. It is expected vendors will be set up all day.
