**Call to Order**

Chair Orlowicz called the meeting to order at 7:24pm. She explained that with Mr. Sullivan being present via telephone, per state law all votes would be taken with a roll call vote. *New Durham Budget Committee  
January 10, 2018*

Chair Orlowicz stated the purpose of this meeting is for the proposed budget for the 2018 budget period to be presented to the public for comment and read the Public Notice posted for this meeting.

Chair Orlowicz explained the Board of Selectmen and Budget Committee worked collectively to develop a budget within 1% of the 2017 budget and noted the 2018 budget is an overall increase of \$160,200 compared to the 2017 operating budget. She summarized the review process conducted by the department heads, board/committee chairs, Board of Selectmen and the Budget Committee.

Chair Orlowicz reviewed the accounts with approved amounts, with public comment to follow.

Mr. Swenson explained during the discussions it was noted there are increased costs with having contracted services and reiterated the offsetting revenues.

## **2018 Town Warrant Articles**

Chair Orlowicz stated the discussion will begin with Article 7 to determine if the Budget Committee will recommend the articles. The committee reviewed the warrant articles.

Chair Orlowicz read Article 7.

**Article 7:** *To see if the Town will vote to authorize the Selectmen to enter into a long-term lease / purchase agreement in the amount of \$157,000 payable over a term of 3 years for replacement of the Fire Department's Self Contained Breathing Apparatus (SCBA) and to raise and appropriate with the down payment amount of \$51,000 to come from the Fire Department Ancillary Capital Reserve Fund. (3/5 ballot vote required)*

*Estimated 2018 Tax Rate Impact: \$0.00 per \$1,000 assessed valuation.*

Chair Orlowicz read Article 8.

**Article 8:** *Shall the Town raise and appropriate as an operating budget, not including appropriations by special warrant articles and other appropriations voted separately, the amounts set forth on the budget posted with the warrant or as amended by the vote of the first session, for the purposes set forth therein, totaling \$2,899,086. Should this article be defeated, the default budget shall be \$2,769,786, which is the same as last year, with certain adjustments required by previous action of the Town or by law; or the governing body may hold a special meeting, in accordance with RSA 40:13, X and XVI, to take up the issue of a revised operating budget only. **Majority Vote Required***

*[Note: Operating Budget & Default Budget includes the Library Budget.]*

*Estimated Tax Rate Impact – 2018 Proposed Budget: \$ 4.84 per \$1,000 assessed valuation.*

*Estimated Tax Rate Impact – 2018 Default Budget: \$ 4.52 per \$1,000 assessed valuation.*

Mr. Meyer asked who the “governing body” is. It was explained that in this context it is the Board of Selectmen.

**Article 9:** *To see if the Town will vote to raise and appropriate the sum of \$381,700 for the purposes of a **Road Program** with \$114,700 to come from Highway Block Grant Aid, \$209,000 to come from taxation, and the remainder of \$58,000 to come from the Road Construction Capital Reserve Fund. **Majority Vote Required***

*Estimated 2018 Tax Rate Impact: \$ 0.51 per \$1,000 assessed valuation.*



Mr. Bickford questioned why they didn't use funds from the unassigned fund balance instead of the capital reserve to help keep the tax rate down. Mr. Swenson stated the Board of Selectmen considered various funding options and noted it was unclear what the fund balance will be at the end of 2017 and funds were already used elsewhere from the balance. Mr. Bickford questioned the amount for the assessing and stated it seems like a significant increase and asked why it couldn't have been used for the roads. Mr. Swenson stated the Board of Selectmen determined the money needs to be maintained for the upcoming cyclical assessing costs.

Chair Orlowicz asked if the committee wants to consider using funds from the unassigned fund balance. Town Administrator Kinmond explained the suggestion is to use the unassigned fund balance in place of taxation and noted the Board of Selectmen look at all monies available and make application which directly affect the tax rate and disagrees with applying the monies at this point. He recommended applying the revenues at tax rate setting time as available. Mr. Bickford stated there is over \$1,000,000 in the balance so they do know what is in there. Town Administrator Kinmond recommended they need to have a larger balance (higher percentage of 10%) to utilize for various project for towns to be able to utilize the unreserved fund balances, noting it won't make much of a difference to use the money now or then. Ms. Jarvis stated she was on the Board of Selectmen when the 8% unassigned reserve fund balance was set and the information supporting that percentage was determined to be inaccurate and would prefer to wait for more information and a higher percentage.

Further, to name the Board of Selectmen as agents to expend from said fund. (Majority Vote Required)  
Estimated 2018 Tax Rate Impact: \$0.002 per \$1,000 assessed valuation.*

***(Majority vote required)***

*Estimated 2018 Tax Rate Impact: \$0.08 per \$1,000 assessed valuation.*
