Eversource:

Work order has been initiated for a street light to be installed at the corner Saint Moritz Drive and Mountain Drive, where the school bus is picking up and dropping off students.

Plow:

Water Bill Increase:

Water bill has been increased to \$850 per year. The bills are due quarterly, the first one is due at the end of March.

<u>Liens</u>: Intent to Lien notices have been mailed out to any water resident that has not paid their past water bills as of December 31, 2019. For those residents that have had an intent mailed to them in January of 2020 that have not responded either with payment, or with a plan for payment, a lien will be placed on their CCVD Property/Resident at the end of the 30 day notice.
