- Ellen's son-in-law is a CPA can help in 2-3 months
- Nicole Zoltko can help if needed
- by-laws work is almost done
- should revisit list of officers
- Question: are Selectmen on board with this?
- Nicole: 501C3 has nothing to do with the Town; creates a separate group
- once done, Meetinghouse projects would be eligible for federal grants

Historic district

- first step apply for certified local government status
 - this is the job of the Selectmen they should take the lead to apply
 - due by March
 - needs to be placed on warrant
- this would open up things that would be helpful

 - November newsletter brought in most donations
- clothing shed
 - Per Clayton Randall; Jon Mouradian will continue to help for a while, but feels the Town should bear the responsibility; it requires many hours to oversee.

Other Business

Discussion of the committee's charge relating to fundraising. Greg and Janis Anthes felt that fundraising was not in the committee's charge. Bob Bickford and Ellen Phillips disagreed, saying that the Selectmen had made it clear that it was the committee's job to conduct fundraisers. Greg Anthes indicated that if it was him, he would be targeting people for donations in the range of \$10,000, but he did not want to work on it with this committee.

Recent actions by the Board of Selectmen have upset townspeople; some are backing out of their commitment to purchase a memorial stone and are asking for a refund. Committee members should talk to them and try to keep the momentum going.

Clayton Randall asked if there was an emergency fund. Nicole Zoltko, Town Adminstrator said there is not; to access funds for an emergency needs approval from various people.

David Bickford stated that meetings should be in a room that is ADA accessible. Nicole Zoltko, Town Administrator, responded that she had asked the Town's Department of Public Works if the rear steps could be changed to a ramp and they said yes.
