# 1772 Meetinghouse Restoration Committee Meeting Minutes for May 11, 2023 Approved June 20, 2023

### Call to Order

# Financial Report

Total donations for the period from April 23, 2023 to May 8, 2023 was \$2,705.46. This was for the sale of 2 commemorative stones (@ \$1000 each), clothing shed (\$154.46), and donations received from visitors and sponsors and merchandise sold at the Spring Fling event (\$551) Current balance of the expendable trust fund is 27,785.76. Current balance of the CRF is \$88,000. Total for both accounts is \$115,785.76
