**Strafford Regional Planning Commission- Land Use Suitability Map**

Vice Chair Craycraft stated the SRPC representative will be coming to the April 16 meeting and suggested they put together their questions and concerns about the maps for discussion at that meeting. The Board reviewed and discussed the draft maps and overlays. Mr. Drummey suggested adding property lines. There was also discussion of having the Road Agent and Town Administrator present for the meeting to review the overlays with SRPC. Selectman Veisel suggested making sure certain landmarks such as the fish hatchery are included. Mr. Drummey will draft a list of questions prior to the workshop for review by SRPC.
