Conditional Use Permit/Site Plan Application, Eugene Dean, regarding Map 257, Lot 001

The Board discussed the need to review the meeting minutes of the previous case for the Notice of Decision for Eugene Dean, regarding Map 257, Lot 001; there are concerns about where concrete or oil pans are needed to contain any oil spillage. Mr. DeCoff suggested they also review the Town Engineer Report. He also suggested they contact the Fire Chief and determine if this new building needs to have fire suppression sprinklers.

New Durham Development Committee

Chair Allard stated the New Durham Development Committee held a meeting recently. He stated there was a lot of discussion and research regarding short-term rentals and there was a suggestion to hold a community event to see what the Town wants. Likely to be held during the summer. Chair Allard stated he would like to get input from towns who have addressed this issue and see how they are handling the situation. Chair Allard stated Cathy Orlowicz has joined the Committee to share her historical knowledge of the town.

HOP Grant for Master Plan Revisions

Mr. DeCoff stated the Board of Selectmen Chair signed the grant application for the Master Plan project which needs to be completed by July.
