Call to Order

Chair Jarvis called the meeting to order at 7:07pm.

Agenda Review

Chair Jarvis added Discussion for Appointment to fill Mr. Hoover's position; an additional Non Public meeting needs to be added to today's agenda.

Approval of Minutes

Meeting of June 11, 2019 – Edits were made. <u>Ms. Richard made a motion to approve</u> the minutes as amended. Ms. Callaway seconded the motion. Motion passed, 4-0-2. Mr. Wessel and Ms. Anderson abstained.

Meeting of June 27, 2019 – Edits were made. <u>Ms. Callaway made a motion to approve</u> the minutes as amended. <u>Ms. Richard seconded the motion. Motion passed</u>, 3-0-3. Mr. Wessel, Ms. Anderson, and Mr. Raslavicus abstained.

Mr. Hoover joined the meeting at 7:24pm.

Announcements

Chair Jarvis stated a letter dated July 25, 2019, was received from Mr. Hoover indicating his resignation effective August 14, 2019. She stated it is with great regret that she accepts his resignation and thanked Mr. Hoover for his many years of dedicated and knowledgeable service. Several members of the public spoke of Mr. Hoover's service to New Durham

Mr. Hoover left the meeting at 7:50pm.

Meeting of July 9, 2019 – Edits were made. <u>Mr. Wessel made a motion to approve the</u> <u>minutes as amended. Ms. Richard seconded the motion. Motion passed, 5-0-1. Ms.</u> Anderson abstained.

Final Review of Draft Procedures

Chair Jarvis stated all the changes agreed to at the last meeting have been accepted and a few items are still being researched. Ms. Richard asked if the Board has ever begun their meetings with the Pledge of Allegiance. Chair Jarvis replied no and the Board agreed it is typically too controversial of an issue. Chair Jarvis stated the instructions for applicants also needs to be updated. The Board reviewed and discussed the edits made to the draft Procedures. Chair Jarvis stated she consulted Town Counsel regarding items in question and explained the edits that were made in response to the advice received. The Board concurred with the edits made and to have Ms. Callaway review for final grammar and spelling edits.

<u>Chair Jarvis made a motion that draft #3 of the Rules and Procedures for the Town of New Durham Zoning Board of Adjustment as amended at the August 13, 2019 meeting proceed to Town Counsel for review and comment after final review for spelling and grammar edits. Mr. Raslavicus seconded the motion. Motion passed, 6-0-0.</u>

<u>Chair Jarvis made a motion to accept the resignation of Art Hoover from the</u> <u>Zoning Board of Adjustment, effective August 13, 2019, with great reluctance. Ms.</u> <u>Anderson seconded the motion. Motion passed, 6-0-0.</u>

Chair Jarvis made a motion to appoint Paul Raslavicus as a regular member of the Zoning Board of Adjustment until the March 2020 election. Ms. Richard seconded the motion. Motion passed, 5-0-1. Mr. Raslavicus abstained.

Next Meeting

Chair Jarvis noted she would not be present for the September meeting. She noted it is unknown whether there will be any hearings at that meeting at this time.

Other

Ms. Zuzgo requested a change in the process for handling certified mailers, explaining that as postage has increased, it has become a problem with having applicants covering the costs and using stamps. She asked that the costs be added to the application fee so she could use the mail machine at Town Hall for postage. The Board concurred with having Ms. Zuzgo use the mail machine for postage.

Motion passed, 6-0-</u> <u>0.</u>
