# **Discussion on ZBA Procedures and Changes**

The Board reviewed the ZBA procedures and discussed proposed changes. Chair Jarvis asked members to consider what additional information could be required on the applications and site plans. She noted currently public notices are printed in newspapers which runs \$100-\$300; the recent legislation allows towns to post the "newspaper" ads on the town website and asked if the Board would be in agreement.

Chair Jarvis stated the Land Use assistant suggested lengthening the time when a case has to be heard from the date of submittal although she will have to look into the RSA. The Board agreed with looking into this change.

Ms. Richard noted full size plans are required and asked if that is something actually looked at and used. Ms. Callaway stated she finds it useful to have a full size. Chair Jarvis concurred. Vice-Chair Anderson stated she uses both the full and smaller sizes.

# **ZBA/Planning Board Subcommittee Update**

Ms. Richard stated the subcommittee has had trouble getting meetings together but at the last meeting they identified four areas to revisit and were assigned tasks for researching ordinances in other towns. Mr. Raslavicus stated one issue was the definition of "footprint". Ms. Richard stated they also discussed the inconsistencies and redundancies in regards to setbacks, deck issues, building height, etc. The Board also discussed other issues that could be looked into by the subcommittee.
